#### SA CHARGING FOR PICK UP IN THE SHORT STAY CAR PARK

#### Minute sa24

Charging area – cant and dean, met eith perry and wrote to Andy Williams, - have a reply from BAA. Members ocncerend council had entered into agreement with no pick up charge. – it was expected, and suprise when charge was introduced.

John Williams – part 4, becasue doesnt make ref to type of people using car park. All users of public transport need to use a levy. 4.1 makes clear that all use of public car parks must use a levy. Ensure that MPs and MEPs and staff have to pay. Part 7.2 – if anyone parks over15 mins will have a penalty. Purpuse is to raise funds for public transport. It would be hard to make an exemption for some people. As it would be contrary to agreement.

Cheetham – a few previous MDs said there was an agreement for a pick up area. Had assurance that the 15 mins would be free. – its not in the spirit of original agreement. – cant pay cash at barrier, only plastic.

Cant – dangerous cos ppl push cases onto road. Not talking about parking, but waitign time.

J Williams – part 4.1 – refers to use.

Wilcock – prob with definition of 'pickup time' – there is not point where can do it successfully. Need to challenge legally. Its only an income generator for airport. There is no policing of area. Propose go back and ask perry to go back to court.

Lemon – card payment for £1 is a joke – practical issue.

J williams – dont have to collect cash adn cards are more secure. BAA fell they re meeting hte agreement.

Godwin – season ticket holders – need to make a provision for commuters into london.

Williams – are in line with industry practice.

Part 7.2, complying to teh agreement.

Cheetham – increased parking for all day –

Wilcock – who drafted wording? M perry adn committee agreed wording. Majority of people spend over 15 mins

Godwin – BA staff are parking reg at birchanger. Causes huge irritation. Williamson – employees have to pay to use public transport – but some companies pay for their so they don't have to pay in staff car park.

Propose – ask M Perry to get something in writing about parking V waiting. Clarify pick up. And ask to see first draft of document. agreed

### SA RECENT AVIATION RELATED REPORTS AND CURRENT CONSULTATIONS

At last meeting there had had been a response from gov.

White paper on trans has now been issued. Progress report, not a consultation doc. Ned to look at carefully, esp gov recognition on env challenge.

Local env challenge - weight on civil aviation act - that will introduce new powers. Measures re on a vol basis.

Reassert eco benefits of aviation travel. Heathrow – making mre use of existing runway. Stn – anticipates planning app for 2<sup>nd</sup> runway. Talks about e

TRANSPORT STUDY – EMPHASIS ON INVESTING IN THOSE BITS OF SYSTEMS that suffers from congestion. We can press gov

Barker review of planning – main imps are of enq commission to deal with major infrasrututer issues.

Gov are sponsors of economic contribution – nothing new.

Paper from SASig also looks at airort guidance manual. Wasn't as helpful as could have been.

1 conultation that good p34 – office of fair trading. OFT believes that BAA s owenerhsip is not in interiest of consumer. View is that its hard to find an angle where Las can respond with info that will be useful. Whilst OFT identified evnince of "old plating" in the way baa provides infrastructure – we can point out that it may not be necessary.

Dean – some ppl met Kate Barker – should challenge gov to justify its position. Pg 11, eco benefits – its not an eco benefit.

Cheetham – for every £1 that comes in from foreign visitors £2.88 goes out with brits travelling. Unblocking conjection – RG – edington only talks abouts concepts no projects. Can respond to authors. Could lobby to influence what goes into white paper.

Expect to pick up these areas at the workshop.

Wilcock – charimans advisory group –  $19^{th}$  jan – if look at reportd esp OEF. Need to look at who funds the studies, often funded by aviaton industry. Gov have a lot of conflicting info. Quality of report is good for us to use – it's a good report.

Future of aiprpot progress report - pg 3, rec 2 - should ask sasig to push methodology. , strong discussion - original intention was for members of sasig. Should take forward the policy about using flying for council business. Propose - that its worked into cncl policy. Make a clear "statement minisation of aiport travel and other forms of travel where possible". AGREED
