Summary

- 1. Notice was given on 14 October by Cllrs Fairhurst, Gerard and Light of the formation of a new political group (the "Green Party Group") on the Council. The formation of a new group triggers the need for the Council to review the allocation of seats on committees in accordance with the political balance rules. This report considers the political composition of the Council and recommends that seats on the main committees be allocated to the five political groups as detailed in the report.
- 2. Following the formation of the Green Party Group on 14 October 2019, the Council is comprised of 23 Residents for Uttlesford, 7 Liberal Democrats, 4 Conservatives, 3 Greens and 2 Uttlesford Independents.

Recommendations

- 3. That the Council reviews the allocation of seats on its committees and achieves political balance by allocating seats as detailed in the report.
- 4. That the Council decides how to allocate three seats between the Green group (2 seats) and the Independent Group (1 seat) on the Governance, Audit and Performance, Licensing and Scrutiny Committees respectively.
- 5. That the Council increases the size of the Standards Committee from eight to nine members.
- 6. That the Council makes appointments to committees in accordance with the nominations made by group leaders.

Situation

- 10. The Local Government Housing Act 1989 requires local authorities to allocate the seats on their committees to political groups represented in accordance, so far as reasonably practicable, with the following four principles of proportionality:-
 - a) that not all seats on the body concerned are allocated to the same political group;
 - that the majority of the seats on the body is allocated to a particular political group if the number of persons belonging to that group is a majority of the authority's membership;
 - c) subject to paragraphs (a) and (b) above, that the number of seats on the ordinary committees of an authority which are allocated to each political group bears the same proportion to the total of all the seats on the ordinary committees of that authority as is borne by the number of members of that group to the membership of the authority;
 - d) subject to paragraphs (a) to (c) above, that the number of the seats on the body which are allocated to each political group bears the same proportion to the number of all seats on that body as is borne by the number of members of that group to the membership of the authority.

11. Ahead of any decision by Council, it has been assumed the number of seats on ordinary committees of the Council (excluding Standards Committee) will be as follows:

12. Based on the 42 seats, the number of seats available to each group is as follows:

Standards Committee

13. The Council's Constitution recognises that that the rules of political balance contained in the Local Government and Housing Act 1989 apply but acknowledges that a politically balanced Standards Committee would be undesirable. It provides that subject to no member present voting against the proposal each political group on the Council would have at least one member on the Standards Committee. The aim is to achieve an even balance on the Committee.

Article 9 of the Constitution provides for three nominations for each political group, until the point when the Committee reaches a maximum of 9 members. As there are now 5 political groups it is proposed that the number of seats on Committee is increased to 9 and that membership should be allocated as follows:

Proposal for Allocation of Seats

14. The allocation of the 51 seats is largely straightforward and is shown below. However, there is a complication in that the Green group is entitled to a seat on two seats out of three committees – GAP, Licensing and Scrutiny. The Independent Group is entitled to one seat on these committees. For illustrative purposes, this shows the Independent Group seat allocated to the Scrutiny Committee and the Green Group seats allocated to GAP and Licensing. However, this is a choice for Council.
