## Summary

1. The Localism Act 2011 introduced a right for communities to draw up neighbourhood plans. Newport Quendon & Rickling Parish Council, with support and advice from the District Council, has produced a neighbourhood plan which has subsequently undergone a successful examination and referendum. This report considers whether the Newport Quendon & Rickling Neighbourhood Plan should be **made** (the Neighbourhood Plan legislation's term for adopted) by the District Council as part of the statutory development plan.
2. A neighbourhood plan, once 'made', forms part of the statutory development plan and sits alongside the Uttlesford Local Plan Adopted 2005. Should planning permission be sought in areas covered by an adopted Neighbourhood plan, the application must be determined in accordance with both the neighbourhood plan and the Local Plan unless material considerations indicate otherwise.

## Recommendations

3. That the Newport Quendon & Rickling Neighbourhood Plan be formally 'made' as part of the statutory development plan for the District.

## Financial Implications

4. The two examinations that cost **£13,961.82** and **£1,350.00** respectively **and** referendum costing **£2,651.21** were initially funded by Uttlesford District Council. UDC will be able to claim up to £20,000 funding from MHCLG which will cover the cost of the examinations and referendum.

## Situation

7. The parish of Newport Quendon & Rickling was designated a neighbourhood plan area on 4 December 2014. The Neighbourhood Plan group then gathered evidence and undertook significant consultation. Pre-Submission consultation under Regulation 14 was undertaken between 23 July and 21 September 2018.
8. The Newport Quendon & Rickling Neighbourhood Plan was submitted for Examination on 1 August July 2019. The examination was conducted via written representations as the Examiner decided that a public hearing would not be required. The Examiner's Report, detailing recommendations was received on 29 September 2019.
9. On 24 November 2020, Cabinet having considered each of the recommendations made by the Examiner resolved that the Newport Quendon and Rickling Neighbourhood Plan be modified as set out, be subject to a seven-week consultation (17 September - 29 October 2019), progress to Referendum subject to no substantive representations being lodged. On 2 February 2020, after the seven -week consultation period the Director of Public Services, in consultation with the Planning Portfolio Holder considered responses to the consultation, accepted and endorsed the proposed changes to the Neighbourhood Plan and supported the Plan to go forward to referendum.

10. A referendum was held in Newport Quendon & Rickling Parish on **Thursday 6 May 2021** posing the following question to eligible voters:

*“Do you want Uttlesford District Council to use the neighbourhood plan for Newport Quendon & Rickling to help it decide planning applications in the neighbourhood area?”*

11. **44.2%** of registered electors recorded votes, **1,178** votes were cast of which **1,066 or 90.5%** were in favour of ‘Yes’ and **112 or 9.5%** votes in favour of ‘No’. It was therefore declared that more than half of those voting had voted in favour of the Newport Quendon & Rickling Neighbourhood Plan.
12. In accordance with the Neighbourhood Planning Regulations, following the outcome of the referendum it is now for the District Council to **‘make’** the neighbourhood plan so that it formally becomes part of the development plan for Uttlesford District.
13. Section 38A of the Planning and Compulsory Purchase Act 2004 (as amended) sets out the requirement for a local planning authority when it comes to making a neighbourhood plan. It states that:

*“(4) A local planning authority to whom a proposal for the making of a neighbourhood development plan has been made –*

*(a) must make a neighbourhood development plan to which the proposal relates if in each applicable referendum under that Schedule (as so applied) more than half of those voting have voted in favour of the plan, and*

*(b) if paragraph (a) applies, must make the plan as soon as reasonably practicable after the referendum is held.*

*(6) The authority are not to be subject to the duty under subsection (4) (a) if they consider that the making of the plan would breach, or would otherwise be incompatible with, any EU obligation or any of the Convention of the rights (within the meaning of the Human Rights Act 1998).”*

14. As a result of the outcome from the referendum and in accordance with the aforementioned legislation the Council is legally required to bring the plan into force following the successful referendum. It is recommended that the plan is formally made by the Council to become part of the development plan for the district and to help determine planning applications in the parish.

# Agenda Item 4

## **The cross-party motion for a Vote of No Confidence in the Leader and Cabinet of Uttlesford District Council**

The Leader and Cabinet of Uttlesford District Council have failed on a number of fronts to the detriment of our residents. This is a direct result of the lack of transparent, accountable and honest leadership which has been consistently demonstrated during the past two municipal years through the following unacceptable actions and behaviours and failure of leadership that must not be allowed to continue.

### **1. A FAILURE TO DEFEND DEMOCRATIC DECISIONS**

The Council Leader and Cabinet failed to uphold the Planning Committee's decision to unconditionally refuse Stansted Airport Limited (STAL) permission to expand Stansted Airport to 43 million passengers per annum. In so doing they compromised the Council's case at the recent appeal hearings. Furthermore, the same leading Members have unacceptably failed to be accountable by not answering sixteen questions about the appeal process posed by other Members in January 2021.

### **2. A FAILURE OF GOOD GOVERNANCE**

The Council Leader and Cabinet have failed to run the Council in a proper manner and have demonstrated a lack of Good Governance. The same leading Members have refused to call upon parties involved in an ongoing 14-months' long Police Investigation and to follow good practice and to stand aside until the investigation's completion, thus causing substantial reputational and financial damage to the Council. Until the Police and any internal investigation are completed the external auditor is unable to sign off the Council's Annual Governance Statement and the Council's accounts for 2019/20.

### **3. A FAILURE OF ACCOUNTABILITY**

The Council Leader and Cabinet have failed to respect the principle of Democratic Accountability. They have displayed dishonesty and have created a bullying and intimidatory culture which tolerates neither dissent nor questioning from backbench members. Elected members who question, or ask for clarification are frequently dismissed, demeaned or intimidated by administration party members, often in a vicious or otherwise inappropriate manner, so effectively suppressing the democratic representation of their constituents.

## **Conclusion**

**Council therefore resolves to pass a Vote of No Confidence in the current Leader and Cabinet and affirms that they are unfit to lead this Council.**
