Summary

1. Following the retirement of the former Head of Paid Service and Chief Executive, the Appointments Committee has undertaken a recruitment campaign to secure a suitable successor appointment for this position.
2. The Appointments Committee met on Friday, 3 September 2021, to interview shortlisted candidates and select a Chief Executive Designate for recommendation to the Council for appointment.

Recommendation

3. That the Council appoints Peter Holt to the post of Head of Paid Service and Chief Executive.

Financial Implications

4. The post is a permanent part of the staff establishment and costs are fully covered within the salary budget.

Situation

5. The former Head of Paid Service and Chief Executive retired from the Council with effect from 31 August 2021, although was on leave from 1 July. The Council approved an interim appointment whilst the Appointments Committee pursued the permanent recruitment of a new permanent Chief Executive.
6. The recruitment campaign ran through August and the Appointments Committee considered all of the applications received. Following technical interviews of the longlisted candidates by the Interim Chief Executive and the recruitment agency, a shortlist of candidates were tested in a broad-ranging assessment centre, the results of which helped inform the Committee in interviewing the final candidates and in reaching its decision on a preferred candidate.
7. Arising from the background assessments and interviews, the Appointments Committee recommend the appointment of Peter Holt. as the Council's next Chief Executive & Head of Paid Service.

8. The recommended candidate, Peter Holt, has extensive local government and leadership experience. Peter has been an independent Strategic Consultant since April 2021 having previously been Assistant Chief Executive and Deputy Monitoring Officer for South Northants Council from 2018. Prior to this Peter held a number of Interim roles dating back to 2013; Lead Peer Reviewer, Powys County Council, Organisational Development and Communication Consultant London Borough of Brent, Crisis Management Consultant Cheshire East Council, Interim Head of Communications and Organisational Development Oxford City Council, Lead Peer Reviewer – Cheshire West and Chester Council for Local Government Association, Interim Head of Communications for Cornwall Council and Renfrewshire Council, Communication and Organisational Development Consultant for London Borough of Brent, Communications Consultant Dorset County Council and Interim Head of Communications for London Borough Camden. From 2009-2013 Peter was Director of Communication and Marketing for Bristol City Council and from 2006-2009 held the same title for Newcastle City Council. From 2004-2005 Communication Director for Northern Ireland Policing Board. 2002-2004 Head of Corporate Communication for City of London Police, 1996-2002 Trust Board Secretary and Head of Communication for Newham Primary Care Trust. He began his career as a Parliamentary Researcher from 1991-1996. He has a Law degree and is currently undertaking an MBA.
9. It is, therefore, recommended that this Extraordinary Council Meeting approves the appointment of Peter Holt as the Head of Paid Service and Chief Executive.
