### **Summary**

1. This report outlines the Council's new Climate Change Strategy with the draft document set out in Appendix 1. This is intended to be a concise Strategy that is easily understood by all. If agreed, it will be supplemented by a more complex and detailed Action Plan that will set out specific targets for the various climate change projects and actions that are needed to deliver the strategy. This will also be supplemented with targeted deadlines, sources of funding and identification of the people/bodies with responsibility for delivering the actions clearly set out. This should be monitored by Scrutiny Committee on a regular basis to ensure targets are being met.

#### Situation

- 7. The Council declared a Climate Change Emergency in 2019. As a consequence, it was agreed to develop a Climate Change Strategy and associated Action Plan to deliver a series of actions and projects to address climate change issues locally and, whenever possible, on a wider scale by linking into projects beyond the Uttlesford boundary (for example, working with Essex County Council on more strategic initiatives). A Climate Change Working Group was established to lead on this and develop the Climate Change Strategy and Action Plan. To do this, the Working Group also set up a series of sub groups to focus on specific topics relating to Climate Change and the actions needed.
- 8. The proposed Climate Change Strategy is set out in Appendix 1. While a lot of work has already been undertaken to produce the associated Action Plan, this work is still to be completed. A key reason for not having completed the Action Plan at present is that the Council has just recently allocated £1 million for climate change projects over three years. The existing draft Action Plan hasn't taken into account this available funding therefore additional work will be needed to assess and recommend the most effective projects to implement. This will require some external expertise to advise on how to best use the £1 million funding to ensure the Council maximises the "carbon reduction per pound" in all associated projects. It is proposed to appoint a Climate Change Project Officer to

support this workstream as the Council currently has a very limited capacity.

9. Subject to Scrutiny Committee's views, it is proposed to then take the Climate Change Strategy to Cabinet on 9<sup>th</sup> February for approval to then submit to Full Council on 23rd February 2021 for formal endorsement.
