Summary

- 1. This report is about the request for the use of S106 funding for the Foresthall Play Ground Improvement Project in the parish of Stansted Mountfitchet.
- 2. Stansted Mountfitchet Parish Council (SMPC) recently became responsible for the majority of the Open Spaces on Foresthall Park including the maintenance and improvement of the various playgrounds that were installed by the estate's developers.
- 3. In Foresthall Park we have identified 3 locations for improvement: Reeve Road, Wilkin's Crescent and Walson Way.
- 4. Stansted Mountfitchet Parish Council believes that the residents and potential users of the playground should be able to voice their opinion on the new play equipment being installed. For this reason, SMPC have undertaken a public consultations exercise for all the above sites and asked the residents for their opinion on the proposals.
- 5. Based on consultation results Stansted Mountfitchet Parish Council propose to install:

- On Reeve Road, install a toddler roundabout to supplement existing static toddler equipment.

- On Wilkin's Crescent, install a reused swing and slide inside the current LEAP area, which can be used by both younger and older children. In addition, SMPC want to install a trim trail suitable for older children (6-12) outside of the LEAP and on a downward slope in order to minimise the visual impact to nearby residents.

- On Walson way the residents require that new seating should be provided so that all ages can enjoy the nature that arises from the nearby SUDS and Open Spaces.

- 1. The total cost of the project is £20,000 and Stansted Mountfitchet Parish Council have received a grant offer of £3,500 from the UDC Community Projects scheme.
- 2. In all three cases, the additional money would be drawn from the remaining

community facilities pot associated with Foresthall Park, which currently stands at £31,864.45.

3. The Parish Council needs £16,500 from the remaining balance from the community facilities pot associated with Foresthall Park and it would leave a balance of £15,364.45 if funding is agreed.

Recommendations

4. Following public consultation, the council has agreed to install more play equipment on the Wilkin's Crescent Play Area and to add additional seating at Watson Green. The proposal has the support of both Ward District Councillors and of County Councillor Ray Gooding to approve funds of £16,500 to Stansted Mountfitchet Parish Council from S106 funds to secure the Foresthall Play Ground Improvement Project

Financial Implications

5. The funding requested will be drawn from ring fenced funds available for this purpose. There are no other financial implications arising from this report.

Situation

- 10. A recent increase in housing and visitors in Stansted is putting strain on the existing play areas which are not currently all age inclusive, the current playground equipment is for children of 2 to 6 years old.
- 11. The planned playground improvements on Foresthall Park are part of a wider plan to provide increased play equipment and socialising opportunities for the residents of Stansted. This new initiative has its roots in feedback to the Council from the young residents of Stansted South who complained that there was no equipment suitable for their age group.
- 12. This initiative is looking to provide new play equipment for younger children and older children (6 to 12 years), as well as providing adult residents with socialising opportunities.
- 13. Stansted Mountfitchet Parish Council has requested a UDC Community Project Grant of £3,500. The Stansted Mountfitchet Parish Council request is for the release of £16,500 of S106 funds from the remaining community facilities pot at Foresthall Park in order to fill the current funding gap. A cost breakdown has been provided by the Parish, for the project work.

14. This is also a worthy project, for which there is support following public consultation and has the support of both Ward District Councillors and of County Councillor.
