Uttlesford Local Development Scheme 2023

1.0 Introduction

- 1.1 The Planning and Compulsory Purchase Act 2004 (as amended by the Localism Act 2011) requires local planning authorities to prepare, maintain and publish a Local Development Scheme (LDS).
- 1.2 This LDS updates the previous Local Development Scheme published in October 2020 and updated in October 2022. It provides information about the Development Plans and other Planning Policy documents the Council plans to prepare.
- 1.3 Whilst not a formal requirement, for ease of reference the LDS also includes information about the main supporting and procedural documents that accompany the Local Plan.

2.0 What is the Local Development Scheme?

- 2.1 The LDS sets out the timetable to produce the Development Plan Documents (DPDs), such as the Local Plan, including key production and public consultation stages. It must be made available publicly and be kept up to date. This enables the community, businesses, developers, service and infrastructure providers and other interested organisations to know which DPDs are to be prepared for the area and when they can participate in their preparation.
- 2.2 This Uttlesford LDS sets out the timetable for the Councils current DPD work. It primarily focusses on the delivery of the Local Pan (2021 to 2041).

3.0 The Uttlesford Statutory Development Plan

3.1 The development plan for Uttlesford consists of a range of documents which guide development within the district. They include Development Plan Documents (DPD's) and Neighbourhood Development Plans that together, along with documents prepared by Essex County Council, form the statutory basis for determining planning applications in the district of Uttlesford (Table 1). The Development Plan includes plans prepared by Essex County Council as the responsible authority for Waste and Minerals.

4.0 New Local Plan 2021 -2041

4.1 Uttlesford District Council have commenced work on the new local plan proposed to guide Development in the district up to 2041. The tables below describes the content, coverage and timetable for the Local Plan (**Tables 2 and 3**), which is also illustrated in **Figure 1**. Further documents will be added to the LDS programme as the need for them becomes apparent and resources allow.

It will include strategic policies as well as non-strategic policies, any allocations for housing and employment and other associated infrastructure requirements.

Replaces – The Uttlesford's Local Plan 2005

6.0 Neighbourhood Plans

- 6.1 Neighbourhood plans are led and prepared by the community, not the Council, although the Council has a statutory duty to provide advice and support to those producing a plan and at prescribed stages in the plan making process. Through these plans local communities have the power to influence the future of the places they live and work.
- Neighbourhood Plans do not need to be included in this LDS as they are not prepared by the Council. However, they do form part of the Statutory Development Plan once adopted and are therefore relevant to future decision making. Furthermore, it is understood the Government intends to maintain the legislation and guidance regarding the preparation and 'making' of neighbourhood plans, irrespective of the proposed changes to local plans. The status of neighbourhood plans in Uttlesford are covered in **Table 1**: The current Uttlesford Development Plan earlier in this document.
