GENERAL NOTICE OF REGISTERABLE INTERESTS

a member of Uttlesford District Council, set out below under the appropriate headings my interests, which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct and I have put "none " where I have no such interests under any heading.

I recognise that it may be an offence under the Localism Act 2011 to:-

- (1) omit information that ought to be given in Section 1 this notice;
- (2) provide information in Section 1 of this notice that is materially false or misleading;
- (3) fail to give further notices in order to bring up to date information given in Section 1 of this notice after my re-election or reappointment or to fail to declare a disclosable pecuniary interest that I acquire after the date of this notice and have to declare under the provisions of s. 31 (2) Localism Act 2011.

I also acknowledge that it may be a breach of the Code of Conduct to:-

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading;
- (3) fail to provide written notification to the authority's monitoring officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change of circumstances

Section 1 - Disclosable Pecuniary Interests

(Members are required to register not only their own interests under this heading but also those of their husband or wife, civil partner or of any person with whom they are living as if husband and wife or as civil partners when such interests are known by them)

1. Any employment, office, trade, profession or vocation carried on for profit or gain	
2. Any payment or provision of any financial benefit (other than from the relevant authority) made or provided within the relevant period in respect of any expenses incurred by you in carrying out your duties as a member or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992	
3. Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority under which goods or services are to be provided or works are to be executed which has not been fully discharged	
4. Any beneficial interest in land which is within the area of the relevant authority	PROPERTY IN WALSTED - FREEHOLD PUDNEY'S, CHURCHWAY END ROAD, WALSTED. CM6 3LU.
5. Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer	
6. Any tenancy where to your knowledge the landlord is the relevant authority and the tenant is a body in which the relevant person has a beneficial interest	
7. Any beneficial interest in securities of a body where – a) that body (to your knowledge) has a place of business or land in the area of the relevant authority; and b) either – (i) the total nominal value of the securities exceeds £25000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class	

Section 2 - Other Pecuniary Interests

(Members are only obliged to register their own interests under this heading and not the interests of husbands/wives/civil partners or others)

The name of the person who employs or has appointed you, the name of any firm in which you are a partner, and the name of any company for which you are a remunerated director.

Section 3 - Registerable Non-Pecuniary Interests

(Members are only obliged to register their own interests under this heading and not the interests of husbands/wives/civil partners or others)

1. Your membership of or the fact that you are in a position of general management and control of any body:-
 - a. to which you have been appointed or nominated by your authority
 - b. exercising functions of a public nature
 - c. directed towards charitable purposes
 - d. one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)
2. The name of any person from whom you have received a gift or hospitality with an estimated value of at least £25
