NOTIFICATION OF A "SENSITIVE INTEREST" UNDER

SECTION 32, LOCAL GOVERNMENT ACT, 2011

I have been elected as a councillor for B INCHANGEN..... I have made a declaration of the interests I am obliged to disclose under the Code of Conduct for my Council.

I understand that the Localism Act, 2011, requires Uttlesford District Council's Monitoring Officer to publish details of my declaration of interests, and to make these available for public inspection, unless they are classed as "sensitive interests" under Section 32 of the Localism Act.
